Seagulls – A Review of 2020's Gull Control Programme

The Committee were very pleased that so many residents supported our involvement with the Council's Gull Control programme and made financial contributions totalling nearly £3,000 which the Council matchfunded. We believe that the measures have been very successful in deterring gulls from successfully nesting on the roofs of our properties and reducing nuisance and noise disturbance.

The weekly "Hawking" exercise was probably the single most visible and successful element as it appears to have discouraged gulls from choosing our area to nest and breed. The contractor's falconer used both a Harris's Hawk and falcons in the area to disturb the gulls while they were trying to pair up and nest.

The use of a second contractor with his elevating work platform to carry out egg replacement was also very

helpful and residents who benefitted from this intervention reported success.

The third element, the gull distress call megaphone, was beneficial initially, although it became obvious to John Ball, the resident who operated it, that the long-established pairs soon got used to the disturbance and started to ignore his attempts to make them lift from their nests.

A further deterrent was tried for a few days, a flag on a long pole waved near the nesting Herring Gulls on 47/48 Britannia Square. It did not seem to be very effective and was soon discontinued.

The combination of these disturbance methods is probably the main reason that little or no successful breeding and fledging occurred in our area. Most of the birds that built nests did not appear to successfully raise chicks, due to the disturbance of their routines.

The gulls' residual nest material was removed from accessible roofs on 6 November, to make it more difficult for the birds to start a new nest next season. At the same time, the upper surface of the chimney stack between 47 & 48 Britannia Square has been painted red, as this is known to deter nesting gulls.

We have contacted various residents who were most affected by gulls in previous years for feedback. All those who responded were positive and several said that if a similar plan is in place for next year, they would be happy to contribute to the costs. This view has been reinforced by other residents. We have not received any negative feedback.

We are all very grateful to the City Council's Gull Control Officer, Gordon Dugan for setting up and operating this programme.

Plans for next year

The Council have confirmed that the Gull Control budget will roll on at much the same level into next year. They intend to determine more scientifically whether it was hawking, nest and egg removal or a combination of both that was the key to success. Therefore next year they will move the hawking activities to the Tything / Upper Tything area, subject to some funding from the organisations and residents' groups there, which only

benefitted from nest and egg removal last year. They will not undertake nest and egg removal in that area.

Conversely, they do not intend to arrange for hawking in our area, only to continue nest and egg removal on four days commencing in May at 21-day intervals. This will be funded by the Council's gull control budget and we will not need to raise any money from our residents in 2021, though if hawking is deemed necessary in 2022 we will be asked to contribute again.

It is anticipated that hawking along the Tything will still have some disturbance effect on the gulls in our area.

New House Painting Guide Now Available

At the Residents' Association AGM in November 2019, there were a number of questions from the floor with regard to the choice of house paint colours in Britannia Square Conservation Area. Whilst the committee was able to cite the current guidance (for 'stone-coloured' paint), there were requests for more information, and some form of guide for reference.

With this in mind, the committee has developed a set of recommendations. These have been developed over six months or so, drawing on the expertise and knowledge of committee members, with input from former Conservation Officer, Will Scott.

'A Guide to Painting Stucco Rendered Façades in the Britannia Square Conservation Area' has now been approved by the current Conservation Officer, Dr. Paul Collins, who will be using it for reference. It will also be included in the information packs sent to residents applying for planning permission.

Neighbourhood Watch

Do you have a car with keyless entry?

In the summer there was an incident in the Square where three youths were spotted attaching a laptop to a car with a view to hacking into the code for unlocking and starting it. Fortunately a passer-by spotted them and they ran off.

If your car has keyless entry, below is some general advice from the ABI.

What can I do to protect my car?

• Don't forget the basics – ensure that your car is properly locked and consider low-tech security measures, such as a steering wheel lock or locked gates, which can make life harder for thieves and could act as a deterrent for criminals who may move on to try to find an easier target.

• Make sure your car keys are kept as far away as possible from doors and windows and, if possible, shut inside a drawer when you are at home.

• You can also purchase Faraday pouches and containers to keep your keys in, which can help block the signal given off by your keys.

• Some keys also have the option of turning off the wireless signal. Consult your vehicle manual or contact the manufacturer to check if your key comes with this feature.

• If the worst should happen and your car is stolen, having a tracking device fitted can help your vehicle to be recovered.
