

Paid up Member?


Of the 120 households in Britannia Square, Albany Terrace and Stephenson Terrace, 52 are current paid up members.



BSRA's General Data Protection Regulation (GDPR)

The General Data Protection Regulation (GDPR) which comes into force on 25th May 2018 requires the Britannia Square Residents' Association to confirm with the residents how we may communicate with them and to publish our Data Policy about what data we keep about them and how we use it and protect it.

Our normal communication is by unaddressed leaflets hand-delivered to every household, such as our newsletters and invitations to our events. As these are not personalised and do not depend on any data we may have about you, these are unaffected by the GDPR and will continue unchanged.

Communications sent by email such as urgent Neighbourhood Watch information, invitations to Wine Club events, etc. are based on lists of residents who have opted in to receive these messages and are affected by the GDPR. We need to record your explicit consent for us to continue to send you these emails. You are all most welcome to opt-in to receive these messages. We may also send you other emails in the future with information relevant to the Association and in accordance with our Constitution. Any changes to this communications policy or the Constitution must be approved by the residents at an AGM of the Association.

The BSRA does not intend to contact residents by telephone. We will publish our Data Policy at www.britanniasquare.org This Policy has been approved by the BSRA Committee, and will be discussed at the 2018 AGM.

Two copies will be provided to allow for two household members who wish give their consent or may prefer differing consents.

GDPR Policy Document

1. This policy document describes how the Britannia Square Residents' Association (BSRA) will handle personal data so as to comply with the General Data Protection Regulation (GDPR).
2. The elected and co-opted Committee Members of the BSRA may hold personal data on behalf of the BSRA. The principal data holder is the Secretary. The contact details of the Committee Members are published in our newsletters. The email address of our Secretary is published on the Contact Us page at www.britanniasquare.org.
3. The BSRA only holds personal data for the specific purposes of the BSRA as defined in its Constitution and for the purposes expressed by our residents, for example their BSRA membership status, and for specific consents to receive emails. This data may consist of the residents' names, addresses and email addresses.
4. The BSRA holds personal data in accordance with good practice standards of personal domestic data security. It is backed up in a secure encrypted format to an external commercial service.
5. The BSRA will not release any residents' personal data to any third parties without the explicit consent of the resident.
6. The BSRA sends emails in such a way that the email addresses of other recipients are not visible.
7. The BSRA will retain residents' personal data for as long as the resident lives in the area of the BSRA, namely Britannia Square, Albany Terrace and Stephenson Terrace, or until the resident requests that their data is amended or deleted. This may be done by contacting the Secretary or any other Committee Member.

BSRA Historical Photographic Record Project

This Spring we continue to focus attention on our photographic project (BSHIP), with the aim to gather as many images of the area as possible and to make them available on our website.

A second batch of photographs from those supplied by the Historic Environment Record is being prepared, which includes some very atmospheric, monochrome images of Stephenson Terrace. We hope to publish these within the next few months.

We are also currently researching and preparing a list of photographs of Britannia Square taken by R.H. Sargeant and H. Sargeant, in order to try to acquire copies from the copyright holders. We believe that the Sargeants were commissioned to make a photographic survey of the area in the 1950s.
