Neighbourhood Watch - Thefts from gardens, sheds & garages

Over the summer, there were several incidents of thefts from gardens, sheds and garages in our area. Items stolen included garden furniture, bicycles and gardening equipment. The Police advise that consideration should be given to improving garden security with dusk to dawn lighting, shed alarms, curtains or screens over shed windows and adding heavy duty padlocks to shed doors. Other useful advice:

- Keep side gates secure and locked at all times.
- Maintain high side and rear boundaries with trellis and spiky defensive planting (over 1.8 metres).
- Consider attaching padlocks to valuable garden equipment, ladders and bicycles, even when stored in sheds and garages.
- Protect groups of garden furniture by winding a security cable or chain through the arms or legs of the pieces.
- Consider using ground and/or wall-mounted anchors in conjunction with cables and padlocks to secure large objects.

Seagulls – AGM discussion on options to tackle the issues of nesting Gulls in our area.

As many of you will have encountered, seagulls cause considerable nuisance to our residents and visitors. You will be be aware that this is a hot topic locally and the City Council is increasingly looking into the issue. Indeed very recently, a Councillor's option for a seagull cull was dismissed by the Council. This unfortunately means that just like this year, the Council has very few gull prevention measures in place for the coming year too.

So following on from the Spring Newsletter, the BSRA's Committee has been exploring options and potential solutions to discourage and prevent seagulls nesting in our area. You will be aware that the presence of gulls is increasing year-on-year in our area, with the noise, mess and aggressive behaviour that results. A number of our residents have experienced an increasing number of gull issues in the past year.

We have been trying to assess the best possible options to keep the problem in-check for our area, and we've been working with Worcestershire Regulatory Services (WRS), the Council, the Gull Forum and some private pest control companies, to look at some suitable options.

At our AGM on 15th November , we will be joined by Mark Cox, Technical Services Manager, for Environmental Health & Licensing at WRS, who is looking closely at gull control measures across the city and now that we have raised the issue, thankfully our area too. He will be explaining the current legislation and licensing covering gull control, gull behaviour and potential health issues, some site specific problems relating to our area and hopefully some proposals for the coming breeding season and what their procedure is for reporting gull problems. We hope that you can join us in the gull debate and discuss the best way forward for our area on this increasing and tricky to solve problem.

With the birds being displaced from some city buildings, they're gradually moving out of the city centre areas to pastures new, and as their numbers increase, our conservation area has many suitable and hard to reach nest sites. So some of the possible control measures that may be considered over the next 3-5 years may include:

- Extra monitoring of the problem in our area.
- Egg replacement scheme extended to cover our area.
- Hawking and falconry flying to deter the gulls from our area.
- Portable lasers to scare the birds.
- Drones to scare the birds.
- Birds of prey decoys, wires and spikes.

Some of these options will, if adopted, incur costs to the Council and our residents, so we have started to look at the potential costs for each option, set against the likelihood of deterrent and success over a couple of breeding seasons. We hope to present these options at the AGM, with a view to getting residents' feedback on the potential to combine financial resources, by clubbing-together to share the costs, in readiness for next year's breeding season. Obviously, the more residents that are prepared to contribute to the Gull Prevention Fund the cheaper it will be for all. The finer details of any scheme will need to be sorted out in due course.

We look forward to discussing this pressing issue after Mark Cox's presentation at our AGM on Friday 15th November at 7.30pm at the URC in Albany Terrace. David Greenhill
